### **47. MINUTES**

The Minutes of the Meeting held on the 15th September, 2008, as circulated, were confirmed and signed by the Chairman.

### **48. SHIPLEY BRIDGE LANE, COPTHORNE**

The Committee noted -

[a] a letter from a Surrey County Council Highways Engineer intimating that there were no proposals and no priority in Surrey for the introduction of a 7.5 tonne vehicle weight restriction along that part of Shipley Bridge Lane in the

County, and that it was felt that there might be objections from local Surrey Councillors, at various levels, to the Order proposed by West Sussex.

[b] a request from the West Sussex County Council asking whether, in the light of the Surrey CC attitude, the Parish Council would formally support the introduction of the proposed 7.5 tonne restriction on that part of Shipley Bridge Lane in West Sussex.

**RESOLVED:** That -

[a] the WSCC be informed that this Council will support any action to impose a 7.5 tonne vehicle weight restriction on Shipley Bridge Lane;

[b] all local Surrey Councillors, at County District and Parish level, be asked for their views on the County Council's attitude in respect of the suggested 7.5 tonne vehicle weight restriction on Shipley Bridge Lane, and asked to support the introduction of such a limit; and

[c] the Clerk be instructed to make further representations to the Surrey County Council Highways Engineers seeking the imposition of the 7.5 tonne limit.
